

# Ramsey School District iPad Insurance

The Ramsey School District has partnered with Worth Avenue Group to offer a specialized insurance plan that will provide iPad coverage for an affordable annual fee. Insurance is required for the privilege of using the iPad outside of the school buildings. Parents of all High School and Middle School students must sign the iPad agreement before iPads will be issued or activated.

**The policy is effective from September 1, 2017 – August 31, 2018. The annual premium is \$ 35.00 per student.** iPads are considered an integral learning tool and are a valuable piece of school property which must be handled with care. Intentional abuse is a serious offense and may be subject to additional fines and possible disciplinary action. **A fine of \$35.00 will be assessed in your child's portal.** Fines will be removed when the payment is received. iPads will be used on the first day of school, so please be sure to complete the registration paperwork and pay the fine prior to Sept 1<sup>st</sup>.

**New for the 2017-18 School Year** – The insurance policy will cover up to 2 incidents of Accidental Damage. After two incidents, parents will be charged a \$50.00 deductible per incident.

**FamilyID** is the vendor we use for registration, which includes a secure payment portal via *PayPal* to accept credit cards. If you wish to pay by check, you may choose "other" at time of payment. **No iPad will be issued or activated without both the registration and the payment.** If you have any questions, please call the Technology Department at 201-785-2300 x 21589 or email [rsdtech@ramseyk12.nj.us](mailto:rsdtech@ramseyk12.nj.us).

- Register in Family ID (see attached instruction sheet)
- Pay by credit card (or your PayPal account) through FamilyID OR
- If paying by check, choose "other" at time of payment in FamilyID
  - Make checks payable to the Ramsey Board of Education Student Fund
  - Issue separate checks if your children attend different schools.
  - Write **your child's name in the memo field.**
  - Bring the check to the main office or media center of your child's school. If mailing your payment, address the envelope to: Ramsey High School Technology Dept. 256 E. Main Street, Ramsey, NJ 07446

## Coverage Includes:

- Accidental Damage including Drops, Liquid Spills and Liquid Submersion
- Theft, Burglary and Robbery (**Police Report Required**)
- Standard Perils: Fire, Flood, Vandalism\* (not intentional), Natural Disasters and Power Surges due to lightning

## Losses Not Covered:

- Corrosion & Rust
- Cosmetic Damage
- Dishonest or Intentional Acts
- Nuclear Hazard
- Power Surge (except lightning)
- Theft from an unattended vehicle
- Unexplained or Mysterious Disappearance
- War-Government Seizure
- Wear and Tear
- Manufacturer's Defects and Mechanical Breakdown
- Chargers, Cords and Cases are not covered by insurance and are subject to a fine if damaged.

# iPad Policy Acceptance & Insurance Payment Instructions

---

The Ramsey School District is a one-to-one iPad environment for 6-12<sup>th</sup> grade. Students are permitted to take their iPads home each day if they have purchased insurance. **The cost of insurance is \$35.00 for the 2017- 2018 school year** and covers repairs and theft, as outlined in the Worth Avenue Agreement. Insurance is renewable on an annual basis at the beginning of each school year. A fine is assessed in your portal until this fee is paid.

- 1. Review our Technology Usage Policies with your children that you will find in both the Parent Portal and within FamilyID. You will be asked to agree to them during registration and the students will be expected to understand their responsibility.**

## **IF YOU DO NOT HAVE A FamilyID ACCOUNT, FOLLOW THE STEPS BELOW TO CREATE ONE.**

### **IF you DO have a FamilyID account, skip to #3.**

- If you **do not** already have an account, select the **CREATE ACCOUNT** button located on the upper right side of the screen and register as a Family.

- To create your secure FamilyID account, enter your first and last name, e-mail address and password. You will receive an e-mail from FamilyID with a link to verify your new account. (If you don't see the email, check your spam or junk folders.)
- Follow the link sent to your e-mail in order to complete registration.
- Registration is created once for the family, then all children can enroll for various programs through your family account.

### 3. **LOG IN AND AND REGISTER FOR IPAD INSURANCE**

Click on the Log in button located on the upper right side of the screen and select the program:

Select the correct school for your child:

**“Eric S. Smith School 2017-2018 iPad Agreement & Insurance”** for grades 6-8 **or**

**“Ramsey High School 2017-2018 iPad Agreement and Insurance”** for grades 9-12

Respond to all questions, read and agree to the policies and agreements listed. **Select “Save and Continue”**. Review your entries then select **‘Complete Registration’**. If you have another child to register, select the correct program for their school and do so completing their information until all children are completed.

### 4. **SUBMIT PAYMENT ON-LINE**

*FamilyID* allows you to pay securely on-line via your PayPal or credit card account, which is preferred. The charge will show up on your statement as Ramsey Board of Education Student Fund. The cost is \$ 35.00 for one full year of insurance per child. A service fee of 2.99% and a .30 transaction fee are added to the cost of on-line processing. You do not need a PayPal account to pay on-line. If using a credit card you will choose the second option with the credit card icons.

### 5. **PAYMENT VIA CHECK or Cash**

If you prefer to pay by check or cash, select **Pay By Other Method** and complete the registration. A check made payable to “Ramsey Board of Education Student Fund” in the amount of \$35.00 per child, with their name entered in the memo field should be brought to the media center or main office. Checks should be separated by school.

If you have a private concern regarding payment, please contact your school principal.

### 6. **REGISTRATION AGREEMENTS ARE MANDATORY**

Regardless of payment method, you must register in *FamilyID* and complete the agreements in order to receive the iPad. Devices are monitored and can be locked until agreements are completed.
